#### **General Use Directions**

Dispense 3M™ Neutral Cleaner
Concentrate 3A with cold water using the
3M™ Flow Control System Wall Mount
Dispenser or the 3M™ Flow Control
System Portable Dispenser into a buddy
jug, 3M™ Easy Scrub Express System
bottles, mop bucket or directly into an
auto scrubber.

Dispense 3M™ Neutral Cleaner Concentrate 3H and 3L with cold water using the 3M™ Twist 'n Fill™ Cleaning Chemical Management System into a buddy jug, 3M™ Easy Scrub Express System bottles, mop bucket or directly into an auto scrubber.

- Dust floors using 3M™ Easy Trap Duster.
- 2. Properly position caution signs for wet floor conditions.
- Mop floor or scrub using an auto scrubber or floor machine with a 3M™ Red Buffer Pad 5100.
- 4. Pick up soiled solution with a wet vacuum or tightly wrung mop.
- 5. No rinsing required.
- 6. Allow floor to dry. Note: Floors may be slippery when wet.
- 7. Burnish or spray-buff immediately after cleaning (optional).
