**4. FIRST-AID MEASURES****First Aid Measures**

<b>Eye Contact</b>	Causes irritation and/or burns and may result in permanent injury to eyes including blindness. Immediately flush eyes with water for 15-20 minutes, while holding eyelids open. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Seek medical attention at once.
<b>Skin Contact</b>	Causes irritation and/or corrosive burns. Brief exposure may cause irritation and defatting of the skin. Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for further treatment advice.
<b>Inhalation</b>	Mists and vapors can irritate the throat and respiratory tract. High vapor concentrations may cause central nervous system effects.
